PHOTOGRAPHIC REPRODUCTION AND USE POLICY

1. Any and all charges incurred by HSW in supplying the materials to the user shall be borne by the user. Special fees may include oversize charges, rush orders, express shipping, dismounting, remounting and rematting. HSW is not responsible if an image does not suit the user's need. The user assumes full responsibility for payment of any charges incurred by HSW. Use fees for publication and exhibit are applied in addition to reproduction fees. See the library's current fee schedule for applicable reproduction and use fees.
2. Requests for permission to reproduce any photographs for publication must be made in writing and accompany the Application for Publication of Photographs form.
3. Permission to use a photographic reproduction is granted for one-time use and only for the purpose specified in this application. Any subsequent or different use must be applied for in writing with by an Application for Publication of Photographs form.
4. Reproduction or duplication of materials supplied by HSW to the user is strictly prohibited. Commercial use or sale of duplicated slides, negatives or prints is forbidden.
5. Any reproduction will be used in its entirety, unless identified as a "detail." Superimposing upon the image, cropping or bleeding off the page is not acceptable without specific permission.
6. Any reproduction of an HSW image that is used on a website must be at a resolution no higher than 72 dpi. The image must also bear the appropriate credit line (SEE BELOW).
7. Upon the date of publication and/or exhibition, the publisher or author must provide the Kiplinger Library of the Historical Society of Washington, D.C. with one complete gratis copy of any publication, film, videotape, CD-ROM, etc. in which photographs are reproduced.
8. Full and proper credit must be given. Each reproduction of an item from the Society's collections shall bear the credit line: "The Historical Society of Washington, D.C." The photograph collection or photographer's name may also be required.
9. The completion of this form does not imply clearance of any copyright restrictions other than those vested in the Historical Society of Washington, D.C. It is the responsibility of the party using the photographs to ascertain and clear copyright restrictions on materials provided from the Society's collection. WARNING OF COPYRIGHT RESTRICTIONS
